FOLLOW ME HOME: A PACKAGED MEDICATION SOLUTION TO SUPPORT COMPLIANCE

Are you worried about your facility's readmission rate and potential associated penalties?

There is a large gap in the transition of care from facility to home. Medication non-adherence and adverse drug events increase patients' risk for readmission. Recent studies have found 26% of all hospital readmissions were medication-related and of those readmissions, 48% were related to non-adherence. Absolute Pharmacy's Follow Me Home (FMH) program can help decrease your facility's readmission risk by providing medications in compliance packaging to your patients at discharge.

FMH Program: Upon Discharge

Absolute Pharmacy will provide a 14-day supply of your patients' daily maintenance* medications, organized by time of day, in our flexPOD packaging.

- Available for patients to take home with them upon discharge.
- Ensures patients have enough medication as they follow-up with their primary care provider(s).
- Patients' insurances will be billed for medications provided, and copays are due at the time of service.
- Absolute Pharmacy will check in with patients approximately one week after discharge and notify caregiver(s) of any issues detected.

FMH Program: flexPOD Packaging

Most patients at home have difficulty taking medications as prescribed and many patients worry that they may have missed a dose. Absolute's Follow Me Home program helps make it easy for patients to manage medications and have confidence they are taking their prescriptions correctly!

- flexPOD Compliance Packaging
 - Medications are separated in PODS and organized by date and administration time (e.g. – morning, lunch, dinner, bedtime).
 - This can help improve adherence by ensuring all medications contained in a pod are taken appropriately and not inadvertently missed or forgotten about.
 - Medications have images of the tablet/capsule included on the flexPOD packaging.
 - This allows the patient to easily identify the medications they are taking.
 - PODS can be easily torn off the main packaging to be taken to appointments, family gatherings, and vacations to ensure medications are still taken appropriately and timely.

FMH Program: Ongoing Maintenance

- Absolute Pharmacy will mail a 28-day supply of patient's daily maintenance* medications, organized by time of day, in our flexPOD packaging.
- Absolute Pharmacy will coordinate all prescription refills for maintenance medications and complete monthly medication review services.
 - Monthly medications are reviewed by the pharmacy team to check for medication interactions and coordinate new or changed therapies in the flexPOD packaging.
 - A yearly comprehensive medication review is provided.
 - Absolute will alert designated caregiver(s) regarding potential issues.
 - Insurance will be billed for medications provided copays are due at the time of service.

Multiple patients from our Skilled and Assisted Living facilities have moved to the Follow Me Home program. This is due to the ease of use flexPOD packaging provides to patients when taking and managing their medications.
